

AND CONCLUDED AT 03.30 P.M.**

- ❖ The 22<sup>nd</sup> Annual General Meeting of the members of the Company was held on Tuesday, 26<sup>th</sup> September, 2017 at 02.00 P.M. and concluded at 3.30 P.M. at the registered office of the Company situated at A-28, Ram Nagar, Shastri Nagar, Jaipur-302016 (Rajasthan).
- ❖ All the Directors, Key Managerial Personnel and Chairmen of all the Committees were present at the meeting. The Statutory Auditors, Secretarial Auditors and the Scrutinizer were also present in the Annual General Meeting.
- ❖ Total 7 (Seven) members were present in person as per the record of attendance.
- ❖ The meeting was chaired by Mr. Krishan Kumar Parwal, Chairman & Managing Director of the Company.
- ❖ The Chairman extended a warm welcome to the members, Directors, Statutory Auditors, Secretarial Auditors and Scrutinizer and others present at the meeting.
- ❖ After ascertaining that the requisite quorum was present, he called the meeting to order. He gave the welcome speech along with the brief introduction about working of the Company, details of performance, achievements and future plans of the Company and thanked for the faith and confidence reposed by them in the Company, it's business and management. He further informed that all the Statutory Registers were open for inspection.
- ❖ He further informed the members that, in compliance with Section 108 of the Companies Act 2013 read with Rule 20 of The Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided the remote E-Voting facility to all the members entitled to cast their vote on all the resolutions as set out in the Notice of AGM. The remote e-voting period commenced on 9:00 A.M. on Friday, September 22nd, 2017 and ended on 5:00 P.M. on Monday, September 25th, 2017. The Company has engaged the services of NSDL (National Securities Depository Limited) for this purpose.
- ❖ CS Manoj Maheshwari, Practicing Company Secretary, Jaipur (FCS: 3355) was appointed as a scrutinizer for conduct of remote e-voting and physical poll process in a fair and transparent manner and he shall submit Scrutinizer's Report on or before 28<sup>th</sup> September, 2017.
- ❖ The Chairman announced that scrutinizer shall submit its consolidated scrutinizer's report on remote e-voting and polling at the AGM within 48 hours from the conclusion of the meeting which shall also be placed on the website of the Company www.hrb.co.in and the website of NSDL, e-voting Agency www.evoting.nsdl.com

## **ORDINARY BUSINESS:**

1. **Ordinary Resolution** to consider and adopt the audited financial statements of the Company for the financial year ended March 31st, 2017 together with reports of the Board of Directors and Auditors thereon.
2. **Ordinary Resolution** to re-appointment of Mrs. Sunita Parwal, Director, retiring by rotation.
3. **Ordinary Resolution** to appoint new Statutory Auditor for the term of 5 years and to fix their remuneration.

## **SPECIAL BUSINESS:**

4. **Ordinary Resolution** to regularise the appointment of Mr. Vinod Upadhyaya as Director.

Thanking the members for their continuous support, cooperation and confidence towards the Company and participation at AGM, the Chairman announced formal closure of the 22<sup>nd</sup> Annual General Meeting of the Company.


